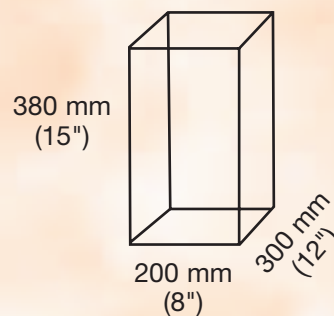

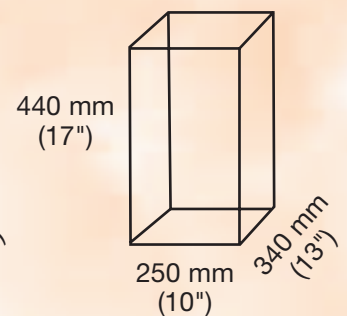

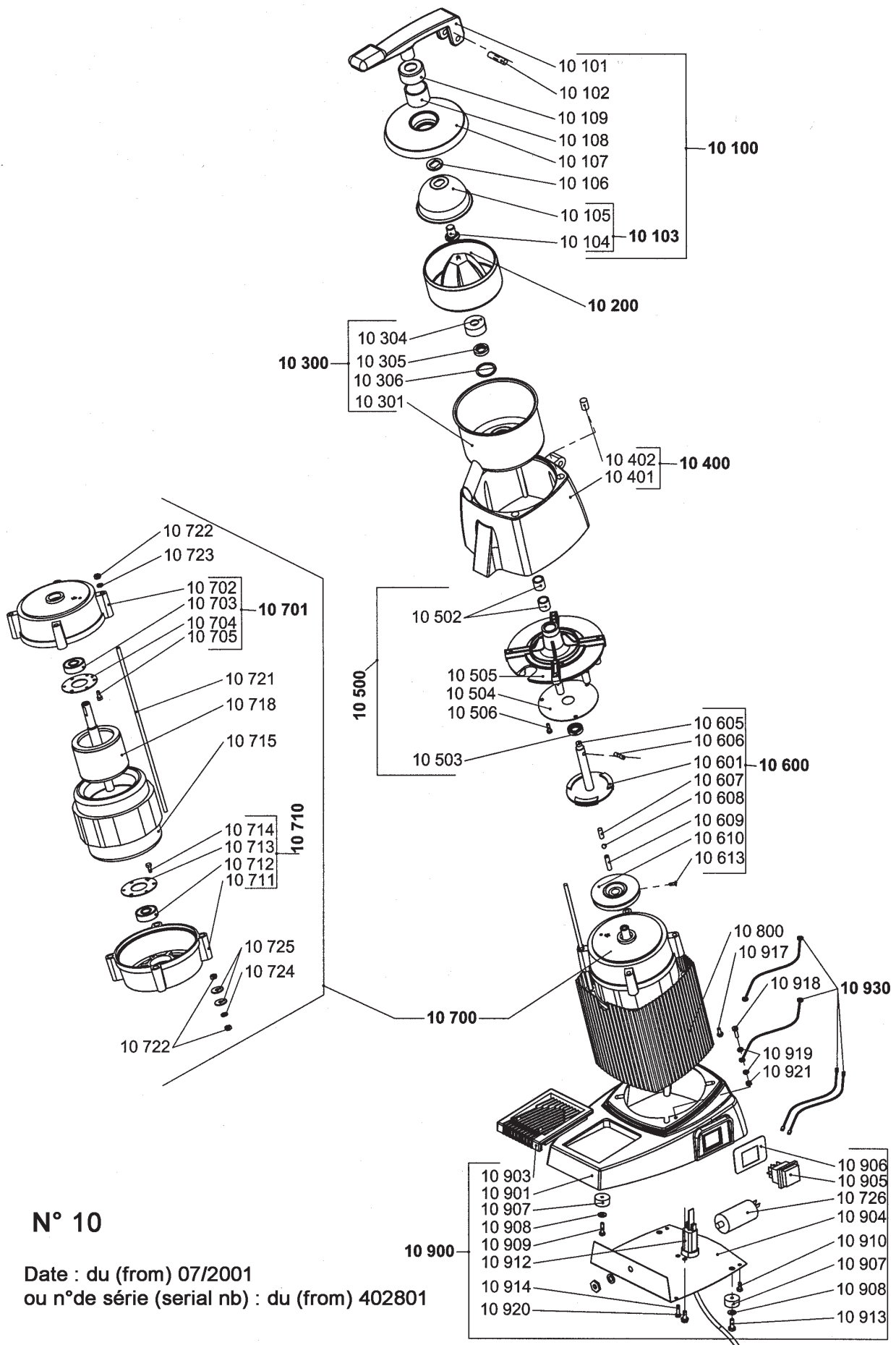
Acoustic safety
